Title, number of pages and language(s) of the notified document:** Arrêté du xxxxx modifiant l'arrêté du 30 décembre 2011 portant règlement de sécurité pour la construction des immeubles de grande hauteur (IGH) et leur protection contre les risques d'incendie et de panique (Order of xxxxx amending the Order of 30 December 2011 establishing safety regulations for the construction of high-rise buildings and the protection of such buildings against fire and panic hazards) (2 pages, in French)
- **6. Description of content:** The notified Order seeks to maintain the restriction on the use of flammable fluids in high-rise buildings and to prevent the creation of a loophole through the reference made by Article GH 37 of the safety regulations for high-rise buildings to Article CH 35 of the safety regulations for establishments open to the public.

Certain Articles of the fire safety regulations for establishments open to the public, most notably Article CH 35, are in the process of being amended with a view to authorizing the use of flammable refrigerants, which until now have been prohibited. Article GH 37(2) of the fire safety regulations for high-rise buildings refers to the provisions of Article CH 35.

- **7. Objective and rationale, including the nature of urgent problems where applicable:** To maintain an adequate level of safety in high-rise buildings pending a specific risk assessment study.
