Description of content: The measure represents a temporary restriction on the importation to the territory of Kazakhstan of live pigs, boar semen, pork meat, including wild boars, and products of its processing, leatherette, horn-test and intestinal raw materials, bristles, hunting trophies obtained from susceptible animal species, feed and feed additives for cats and dogs that have not undergone heat treatment (at a temperature of not less than 70°C for at least 20 minutes), made from raw materials occurring, used equipment for transporting pigs, products and raw materials of animal origin, content, slaughter and cutting pigs from Podkarpatsky region of Poland.
